- Must attend mandatory rehearsal and leadership session.
- Must have 3.0 GPA
- Must have 3 written character references from community.

Dress Requirements:

- Tear Dress or Trade Style Dress (Wrap Skirt, Leggings, Trade Shirt, Finger-woven Belt)
- Pucker Toe Moccasins

Age Eligibility

- Miss Keetoowah must be 18 – 22 years old by 9/17/21
- Jr. Miss Keetoowah must be 13 – 17 years old by 9/17/21
